

# HOUSTON HOEDOWN

## OPEN AIR MARKET

July 25, 26 & 27, 2025

### A. **FEES:**

- (1) Single fee for all spaces is \$25 per space.
- (2) Each space is 15'x15'. Purchase what you need to stay within your space.
- (3) All payments for your space(s) must be received by July 1, 2025. No exceptions.
- (4) Do NOT send cash in the mail. A personal check or money order is acceptable.
- (5) Sites will not be guaranteed if fees and registration are not received by July 1, 2025.

### B. **VEHICLES:**

- (1) No vehicles are allowed in the park during hours of operation.
- (2) Do not park anywhere on the parade route on Sunday.
- (3) No vendor parking is allowed on streets bordering the park (Jackson, Lincoln and Maple).

### C. **ELECTRIC:**

- (1) Electric is not available to vendors. If you require a generator, it must be a campground quiet model. Loud generators must be turned off during hours of operation.

### D. **ITEMS NOT ALLOWED FOR SALE:**

- (1) No drug paraphernalia.
- (2) No explosives of any kind.
- (3) Use common sense. The park manager may ask you to remove any items Considered offensive, dangerous or annoying.

### E. **MINNESOTA SALES TAX NUMBER:**

- (1) The Minnesota Department of Revenue requires all vendors to have a valid Minnesota Tax ID number. Be prepared to show it if asked.

### F. **SETUP:**

- (1) No set up will be allowed during park event hours of operation.
- (2) Hours of operation are:  
Friday: Set-up day. If you will be selling on Friday, be ready to go by 2:00.  
Saturday: 9:00 - 6:00  
Sunday: 9:00 - 4:00
- (3) Check in with Bruce, The Kettle Korn guy, prior to setting up.
